**RESOLUTION OF THE UNION COUNTY UTILITIES
AUTHORITY APPOINTING A SENIOR SOLID WASTE
ENFORCEMENT OFFICER**

WHEREAS, by Resolution 50-2003, this Board approved and adopted job descriptions for, among others, the position of Senior Solid Waste Enforcement Officer; and

WHEREAS, in order to implement an effective and comprehensive solid waste enforcement program, it is the recommendation of the Executive Director and the Personnel Procurement and Insurance Committee that there is a need to appoint a Senior Solid Waste Enforcement Officer; and

WHEREAS, upon consultation with Counsel, the Executive Director and the Personnel Procurement and Insurance Committee have recommended the appointment of David Fernicola as Senior Solid Waste Enforcement Officer at a salary commensurate with the salary negotiated with Teamsters Local 125.

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners of the Union County Utilities Authority as follows:

- 1) The above recitals are incorporated herein as if fully set forth at length.
- 2) This Board hereby authorizes the Executive Director to appoint David Fernicola as Senior Solid Waste Enforcement Officer at a salary of \$48,000.00 which is commensurate with the salary and other terms negotiated with Teamsters Local 125 and currently in force.
- 3) This Resolution shall take effect immediately.
