RESOLUTION OF THE UNION COUNTY UTILITIES AUTHORITY AUTHORIZING THE APPOINTMENT OF AN AD-HOC OVERSITE COMMITTEE WHICH WILL COORDINATE WITH A SIMILAR COMMITTEE OF THE UNION COUNTY IMPROVEMENT AUTHORITY TO COORDINATE AND REPORT TO THE BOARDS ON WORK PERFORMED UNDER THE SHARED SERVICES AGREEMENT

WHEREAS, pursuant to Union County Utilities Authority's ("UCUA") By-Laws, at its April 9, 2014 meeting, the UCUA's Board of Commissioners created a special committee ("Committee") by resolution that will serve together with a similar committee appointed by the Board of the Union County Improvement Authority ("UCIA") to coordinate and report to the UCUA and UCIA Boards on work performed under the Shared Services Agreement previously entered into by and between the UCUA and the UCIA; and

WHEREAS, the Chairman of the Authority has selected two Commissioners to serve upon the said Committee.

NOW THEREFOR BE IT RESOLVED by the Board of Commissioners of the Union County Utilities Authority hereby that Commissioner Eastman and Commissioner Kahn have been appointed to serve on the Committee as described herein above and to report periodically to the Board as to the Committee's activity and the work performed under the Shared Services Agreement previously entered into by and between the UCUA and the UCIA.

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.
