**RESOLUTION FOR THE UNION COUNTY UTILITIES AUTHORITY
DESIGNATING CERTAIN FINANCIAL INSTITUTIONS AS
OFFICIAL DEPOSITORIES FOR THE MONIES OF THE AUTHORITY
IN ACCORDANCE WITH N.J.S.A. 40A:5-14 FOR THE YEAR 2015**

WHEREAS, the County of Union, New Jersey has previously developed the Union County District Solid Waste Management Plan in accordance with the New Jersey Solid Waste Management Act for the purpose of managing the disposal and/or recycling of solid waste generated in Union County; and

WHEREAS, the Union County Board of Chosen Freeholders has designated the Union County Utilities Authority (the "Authority"), in accordance with the Solid Waste Management Act, as the implementing agency for its District Solid Waste Management Plan; and

WHEREAS, the Authority has certain funds which it will have to deposit in financial institutions during the year of 2015; and

WHEREAS, pursuant to N.J.S.A. 40A:5-14, the Authority adopted a cash management plan and is required to deposit, or invest, or deposit and invest, its funds pursuant to that plan; and

WHEREAS, in compliance with the foregoing statute, the Authority desires to designate such financial institutions for deposit and/or investment of Authority funds.

NOW, THEREFORE, BE IT RESOLVED, by the Union County Utilities Authority that in accordance with N.J.S.A. 40A:5-14, the Authority hereby designates the financial institutions appearing on Exhibit A hereto as its official depositories for Authority funds during the year of 2015;

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately.
