**WHEREAS**, the Authority desires to renew said membership;


**NOW THEREFORE, BE IT RESOLVED AS FOLLOWS:**

**AGREEMENT TO RENEW MEMBERSHIP IN THE  
NEW JERSEY UTILITY AUTHORITIES JOINT INSURANCE FUND**

**WHEREAS**, the New Jersey Utility Authority Joint Insurance Fund (hereinafter the Fund) is a duly chartered Municipal Insurance Fund as authorized by N.J.S.A. 40A:10-36 et seq., and;


**WHEREAS**, the Union County Utilities Authority is currently a member of said Fund, and;


**WHEREAS**, effective December 31, 2014, said membership will expire unless earlier renewed, and;

**WHEREAS**, the Governing Body of the Union County Utilities Authority has resolved to renew said membership;

**NOW THEREFORE, IT IS AGREED AS FOLLOWS:**

1. Union County Utilities Authority hereby renews its membership in the New Jersey Utilities Authorities Joint Insurance Fund for a three (3) year period, beginning January 1, 2015 and ending in January 1, 2018. \*12:01 a.m.
2. The Union County Utilities Authority hereby ratifies and reaffirms the Indemnity and Trust Agreement, By-Laws and other organizational and operational documents of the New Jersey Utilities Authority Joint Insurance Fund as from time to time amended and altered by the Department of Insurance in accordance with the Applicable Statutes and administrative regulations as if each and every one of said documents were re-executed contemporaneously herewith.
3. The Union County Utilities Authority agrees to be a participating member of the Fund for the period herein provided for and to comply with all of the rule and regulations and obligations associated with said membership.
4. In consideration of the continuing membership of the Union County Utilities Authority in the New Jersey Utility Authorities Joint Insurance Fund, the New Jersey Utilities Authorities Joint Insurance Fund agrees, subject to the continuing approval of the Commissioner of Banking & Insurance to accept the renewal application of the Union County Utilities Authority.
5. Executed the 15<sup>th</sup> day of October 2014 as the lawful and binding act and deed of the Union County Utilities Authority which execution has been duly authorized by public vote of the governing body.
