RESOLUTION OF THE UNION COUNTY UTILITIES AUTHORITY AUTHORIZING THE CONSTRUCTION OF A MURAL BY THE COVANTA COMMUNITY COALITION ON AUTHORITY PROPERTY ADJACENT TO RIVERFRONT PARK.

WHEREAS, the Union County Utilities Authority (the "Authority") owns certain property adjactent to the Union County Resource Recovery Facility (the "UCRRF"), a portion of which has been dedicated for use as park land, currently known as Riverfront Park within the City of Rahway; and

WHEREAS, the Authority participates in and supports the Covanta Community Coalition (the "Coalition"), which partners with the local community in and around the City of Rahway on a variety community programs and projects; and

WHEREAS, the Coalition has proposed a new project to create a mural within Riverfront Park aimed at celebrating the City of Rahway, the Community and native plants and wildlife, as a means to represent the City and beautify the park, while bringing together a local Rahway artist and multiple citizen volunteers to complete a project for the Community by the Community (the "Mural Project"); and

WHEREAS, the proposed Mural Project would face River Front Park and would be situated on property owned by the Authority, specifically upon an approximately 70 foot long portion of the face of the 16 foot high concrete wall that separates the UCRRF driveway from Riverfront park, and the construction of the Project is not anticipated to impact Authority or Covanta operations at the UCRRF; and

WHEREAS, as proposed, the Mural Project's on-site work is expected to begin no later than early June and be completed by the end of June, with funding to be provided by Covanta Union Inc.; and

WHEREAS, the Authority's wishes to continue collaborating with the Coalition and the broader community as a whole, and to authorize the construction of the Mural Project.

NOW, THEREFORE, BE IT RESOLVED, by the Union County Utilities Authority, as follows:

- 1. The aforesaid recitals are incorporated herein as though fully set forth at length.
- 2. The Authority hereby authorizes the construction of the Mural Project as set forth herein above, under the direction of the Covanta Community Coalition, in coordination with the Acting Executive Director and Covanta Union, Inc.
- 3. This Resolution shall take effect immediately.
