**RESOLUTION AUTHORIZATING THE UNION COUNTY UTILITIES AUTHORITY
TO PROCESS AN INVOLUNTARY DISABILITY RETIREMENT APPLICATION**

WHEREAS, the Union County Utilities Authority (the "UCUA") has employed Employee #12201579; and

WHEREAS, Employee #12201579 is an active member of the Public Employees Retirement System ("PERS"); and

WHEREAS, Employee #12201579 has sufficient years of PERS Service Credit to meet the minimum service credit requirements for PERS members; and

WHEREAS, the Authority has received medical documentation evidencing a good faith basis to believe that Employee #12201579 is disabled and unable to perform the employee's regular assigned duties; and

WHEREAS, the UCUA is unable to provide Employee #12201579 with an alternative PERS-covered position for which the Employee is capable of performing.

NOW, THEREFORE, BE IT RESOLVED that the UCUA Board of Commissioners hereby approves the filing of an Involuntary Disability Retirement application on behalf of Employee #12201579; and

BE IT FURTHER RESOLVED that the UCUA Board of Commissioners authorizes its administration to take all steps necessary to further the purposes of this Resolution, including any acts needed by the Authority's Certifying Officer, and to perfect the application before the Division of Pensions and Benefits; and

BE IT FURTHER RESOLVED that certified copies of this Resolution be forwarded to all interested/affected parties in this action; and

BE IT FURTHER RESOLVED that this resolution shall take effect immediately.
