### AWARDING A CONTRACT FOR REPAIRS TO CERTAIN RIVERFRONT PARK FACILITIES

**WHEREAS**, in order to carry out the stated purposes and goals for which the Authority was created, as well as the powers granted by the Municipal and County Utilities Authorities Law, N.J.S.A. 40:14B-1 et seq., and pursuant to N.J.S.A. 40A:11-1 et seq., the Union County Utilities Authority ("Authority") has determined that it is in need of repair services for the walkway and railings within the Rahway Riverfront Park (the "Services"); and

**WHEREAS**, the Authority solicited competitive quotations through the issuance of a Request for Quotations for the Services to multiple vendors, following which the Authority received two proposals of equal cost; and

**WHEREAS**, after considering all relevant factors, the Authority's staff recommends a contract award for the Services to JD Organic Landscape LLC, as the most advantageous proposal to the Authority, given the Authority's positive prior experience with the vendor and their familiarity, knowledge of and sensitivity to the surrounding park grounds.

**NOW, THEREFORE, BE IT RESOLVED**, by the Union County Utilities Authority as follows.

1. The aforesaid recitals are incorporated herein as though fully set forth at length.
2. The Authority hereby authorizes a contract award to JD Organic Landscape LLC, 2311 Seneca Road, Scotch Plains, NJ 07076, to furnish the services described hereinabove commencing on or after July 18, 2024 with a completion date of no later than October 1, 2024, at a total cost not to exceed \$8,500.00.
3. The Authority hereby authorizes and directs the Authority's Acting Executive Director and Deputy Executive Director to take all appropriate actions, in consultation with the Authority's General Counsel, to effectuate the terms authorized by this Resolution.
4. This Resolution shall take effect immediately.
