1. The proposed 2024 budget revenues decreased approximately \$1,108,000 or 2.3% when compared to the 2023 adopted budget.
  - a) Total Service Charges decreased by \$1,885,205 or 3.9% compared to the 2023 budget. Presentation of the service charges in the 2024 budget have been reclassified to align with the source of the revenues.
  - b) Non-Operating Revenues – Debt Service Reserves in the amount of \$462,400 represent funds on hand that have been anticipated in the 2024 budget to pay debt service principal included in the budgeted appropriations.
  - c) 2024 Non-Operating Revenues – Interest on Investments increased \$314,832 in the 2024 budget based on rates experienced in 2023.
2. The proposed 2024 budget appropriations decreased approximately \$1,108,000 or 2.3% when compared to the 2023 adopted budget.
  - a) Salaries and Wages decreased approximately \$556,000 (or 40.7%) due to reduction in personnel.
  - b) Fringe Benefits increased \$364,880 (or 149.0%) due to a realignment of health benefits as previously budgeted. Also, PERS Pension Assessment was previously budgeted as Other Expenses.
  - c) 2024 Administrative Other – Administrative decreased \$9,377,500 (or 22.3%) for more detail on the specific items see page N-1(3) Below the rate information for Question #6.
  - d) 2024 Total Principal and Interest Payments on Debt Service increased \$8,460,418 (or 196.0%) compared to the 2023 budget due primarily to the inclusion of the debt service payments on the 2011A Lease Revenue Bonds in the 2024 budget.

c) 2024 Administrative Other – Administrative decreased \$9,377,500 (or 22.3%). Highlights of this change are as follows:

- i) Financial Consultant Fees increased \$90,000 mainly due to services provided by consultants which were previously salaried positions.
- ii) Computer Consulting Fees increased \$63,000 to cover costs associated with financial software conversion and tracking ongoing solid waste enforcement.
- iii) Rahway Host Community Fee decreased \$950,000 to reflect costs net of amounts paid directly to Rahway by Covanta in the amount of \$1 million.
- iv) Professional Fees for Legal and Engineering increased \$150,000 based on anticipated projects for 2024.
- v) Service Fee for type 13 waste disposal decreased \$9,240,000 to reflect Authority practice of realizing revenues for type 13 waste net of expenses.
- vi) Service Fees for type 10 waste disposal increased approximately \$508,000 based on projected tonnages and disposal rates for 2024.
