AUTHORIZING THE HIRING OF A SOLID WASTE COMPLIANCE INSPECTOR

WHEREAS, by Resolution 33-2024, this Board authorized the reorganization of the Authority personnel including the titles of Solid Waste Enforcement Officer to Solid Waste Compliance Inspectors; and

WHEREAS, by Resolution 33-024, this Board authorized that the full complement of Solid Waste Compliance Inspectors shall be three (3) in number; and

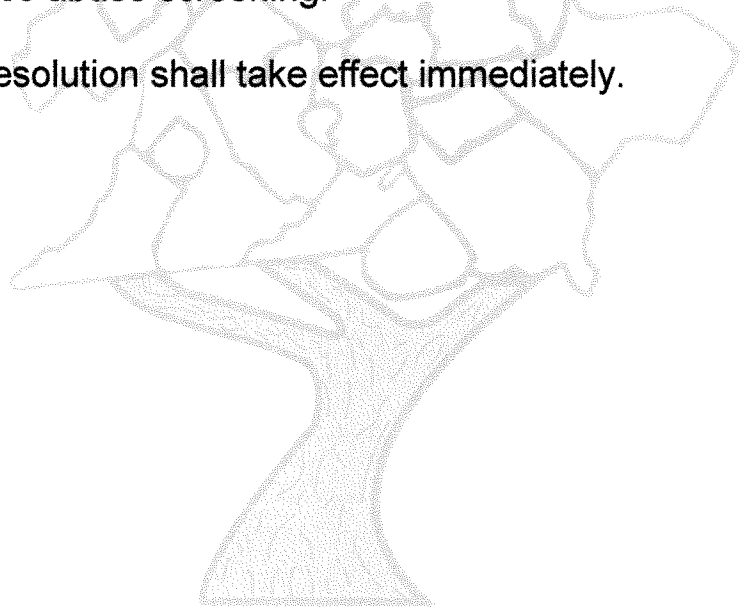
WHEREAS, due to a vacancy in the position of Compliance Inspector, in order to continue implementing an effective and comprehensive solid waste compliance program, it is the recommendation of the Executive Director and the Personnel Procurement and Insurance Committee that there is a need to hire an additional Compliance Inspector to maintain the full complement of such inspectors; and

WHEREAS, upon consultation with Counsel, the Executive Director and the Personnel Procurement and Insurance Committee have recommended hiring Joseph Sweeney as Solid Waste Compliance Inspector at the appropriate salary level provided in the collective bargaining agreement between the Authority and the exclusive bargaining representative for all non-supervisory Compliance Inspectors, Teamsters Local 125.

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners of the Union County Utilities Authority as follows:

- 1) The above recitals are incorporated herein as if fully set forth at length.

- 3) This Board hereby authorizes the Executive Director to hire Joseph Sweeney as a Solid Waste Compliance Inspector, at a salary of \$45,000.00 which is commensurate with the salary negotiated with Teamsters Local 125.
- 4) Said employment shall become effective on or after December 2, 2024. Said employment is subject to the employee listed above providing verification and current New Jersey Driver's License, completion of a criminal history check, physical examination and substance abuse screening.
- 5) This Resolution shall take effect immediately.
