INCREASING THE CAP FOR HINDSIGHT INC., IN THEIR EXISTING PROFESSIONAL SERVICES CONTRACT

WHEREAS, the County of Union, New Jersey has previously developed the Union County District Management Plan in accordance with the New Jersey Solid Waste Management Act for the purpose of managing the disposal and/or recycling of solid waste generated in Union County; and

WHEREAS, the Union County Board of County Commissioners has designated the Union County Utilities Authority (the "Authority"), in accordance with the Solid Waste Management Act, as the implementing agency for its Solid Waste Management Plans; and

WHEREAS, the Authority, in accordance with the performance of its services, and as authorized by the Municipal and County Utilities Authorities Law N.J.S.A. 40:14B-1 et seq., has determined a necessity to authorize the procurement of certain professional and/or other consulting services, including the Authority's February 21, 2024 appointment of Hindsight, Inc., to provide Information Technology services relating to the Authority's operations as set forth in the parties professional services contract; and

WHEREAS, Hindsight, Inc., have exceeded their established monetary cap and are required to request an increase in said existing cap; and

WHEREAS, Hindsight, Inc., have requested an increase in their respective cap and said request has been reviewed by the Chairman of the Authority and Acting Executive Director and found to be warranted; and

WHEREAS, the Chairman of the Authority, Executive Director and the Finance and Budget Committee of the Authority recommend an increase in the cap for Hindsight, Inc., as set forth herein; and

WHEREAS, the Authority has reviewed their request and desires to implement the same.

NOW THEREFORE BE IT RESOLVED, by the Union County Utilities Authority as follows.

1. The Authority hereby authorizes an increase in the cap for Hindsight, Inc., for their 2024 contract with the Authority for an additional \$1,800.00 for a total cap not to exceed \$32,800.00
2. This Resolutions shall take effect immediately.
