RESOLUTION OF THE UNION COUNTY UTILITIES AUTHORITY AWARDING A CONTRACT FOR THE PROVISION OF PARK LANDSCAPING AND MAINTENANCE SERVICES

WHEREAS, in order to carry out the stated purposes and goals for which the Authority was created, as well as the powers granted by the Municipal and County Utilities Authorities Law, N.J.S.A. 40:14B-1 et seq., and pursuant to N.J.S.A. 40A:11-1 et seq., the Union County Utilities Authority (“Authority”) has determined that it is in need of park landscaping and maintenance services, including graffiti removal services as needed, for the Rahway Riverfront Park during the 2025 season (“Services”); and

WHEREAS, the Authority solicited competitive quotations through the issuance of a Request for Quotations for the Services to multiple vendors, following which the Authority received proposals from multiple vendors to provide the Services; and

WHEREAS, after considering all relevant factors, the Authority’s staff has advised that the proposal received on March 14, 2025, from JD Organic Landscape, LLC is advantageous to the Authority, price and other factors considered, and meets the specific needs and requirements of the Authority.

NOW, THEREFORE, BE IT RESOLVED, by the Union County Utilities Authority as follows.

1. The aforesaid recitals are incorporated herein as though fully set forth at length.

The Authority hereby authorizes an agreement with JD Organic Landscape LLC, 2311 Seneca Road, Scotch Plains, NJ 07076, to furnish the Services described hereinabove for a period of thirty (30) weeks beginning on April 15, 2025, and ending on November 30, 2025, subject to the terms set forth in the Authority's Request for Quotations and in JD Organic's proposal, at a total cost not to exceed \$12,000.00

The Authority hereby authorizes and directs the Authority's Acting Executive Director and Deputy Executive Director to take all appropriate actions to effectuate an agreement with JD Organic Landscape LLC in a form to be approved by the Authority's General Counsel under the terms set forth above.
