## ESTABLISHING A MEETING SCHEDULE FOR THE PERIOD MARCH 2025 THROUGH THE AUTHORITY'S REORGANIZATION MEETING IN FEBRUARY 2026.

WHEREAS, the Union County Utilities Authority (the "Authority"), a public body corporate and politic of the State of New Jersey, organized and existing under the provisions of the Municipal and County Utilities Authorities Law (N.J.S.A. 40:14B-1 et seq.) has heretofore been created by the Union County Board of County Commissioners(hereinafter "Commissioners") in order to, among other things, acquire, construct, maintain, and operate or contract for the operation of facilities for the recycling and/or disposal of solid waste generated within the County of Union, New Jersey in an environmentally sound manner; and

**WHEREAS**, the Commissioners designated the Authority as the implementing agency for the County's District Solid Waste Management Plan, in accordance with the Solid Waste Management Act (N.J.S.A. 13:1E-1, et seq.); and

WHEREAS, the Authority constitutes a "public body", as such term is defined in the Open Public Meetings Act (N.J.S.A. 10:4-1 et seq.) (the "Act") and, as such, is required to provide "adequate notice" of any meetings and/or activities of the Authority in the manner provided in N.J.S.A 10:4-8(d); and

**WHEREAS,** in accordance with the provision of N.J.S.A. 10:4-18, at least once a year, within seven days following its annual reorganization meeting, the Authority is obligated to provide "adequate notice", as defined in N.J.S.A. 10:4-8(d), of the schedule of the regular meetings of the Authority to be held during the succeeding year; and

**WHEREAS,** on February 19, 2025, pursuant to Resolution No.: 16-2025, the Authority established a meeting schedule for the year (March 2025 through February 2026), as required by the Act; and

**WHEREAS,** the Authority wishes to amend the meeting schedule for the year, pursuant to the Act.

**NOW, THEREFORE, BE IT RESOLVED,** by the Union County Utilities Authority, as follows:

 During the period of March 2025 through February 2026, unless otherwise indicated on Exhibit A, the Authority shall have one (1) regular meeting per month on the third Wednesday of each month unless otherwise noted. The dates for such meetings are set forth in the Meeting Schedule Notice attached hereto as Exhibit A, which by this reference is made a part of hereof as if set forth in full herein. Unless otherwise indicated on Exhibit A, all regular meetings of the Authority shall be held at 5:30 p.m. via Zoom's virtual meeting online platform administered by way of the Authority's administrative offices located at 1499 Route 1 & 9 North, Rahway, New Jersey, accessible to all members of the public by following the instructions for participation at such meetings set forth in Exhibit A and clicking the meeting link located on the Authority's website: <a href="https://www.ucua.org">www.ucua.org</a>.

- 2. The Clerk of the Authority is hereby directed to take all actions as are required in order to satisfy the requirements of N.J.S.A. 10:4-18, including, but not limited to, (a) prominently posting, and maintaining throughout the year, the Meeting Schedule Notice in at least one public place reserved for such announcements, (b) mailing the Meeting Schedule Notice to the newspapers officially designated by the Authority to receive such notices, and (c) filing the meeting schedule with the Clerk of the County of Union, and electronically mailing this Resolution (including the attached Meeting Schedule Notice) to the Union County Manager and to the Clerk of the Board of County Commissioners of the County of Union.
- 3. This Resolution shall take effect immediately.
