INCREASING THE CAP FOR JD ORGANIC LANDSCAPING, LLC IN THEIR EXISTING CONTRACT WITH THE AUTHORITY

WHEREAS, the County of Union, New Jersey has previously developed the Union County District Management Plan in accordance with the New Jersey Solid Waste Management Act for the purpose of managing the disposal and/or recycling of solid waste generated in Union County; and

WHEREAS, the Union County Board of Chosen Freeholders has designated the Union County Utilities Authority (the "Authority"), in accordance with the Solid Waste Management Act, as the implementing agency for its Solid Waste Management Plans; and

WHEREAS, the Authority, in accordance with the performance of its services, and as authorized by the Municipal and County Utilities Authorities Law N.J.S.A. 40:14B-1 et seq., has determined a necessity to authorize the procurement of landscaping and landscaping related services including the Authority's March 19, 2025 appointment of JD Organic Landscaping, LLC to provide park landscaping and maintenance services relating to the Authority's operations as set forth in the parties' contract; and

WHEREAS, JD Organic Landscaping, LLC has exceeded their established monetary cap and are required to request an increase in said existing cap; and

WHEREAS, JD Organic Landscaping, LLC has requested an increase in their respective cap and said request has been reviewed by the Chairman of the Authority and Executive Director and found to be warranted; and

WHEREAS, the Chairman of the Authority, Executive Director and the Finance and Budget Committee of the Authority recommend an increase in the cap for JD Organic Landscaping, LLC as set forth herein; and

WHEREAS, the Authority has reviewed their request and desires to implement the same.

NOW THEREFORE BE IT RESOLVED, by the Union County Utilities Authority as follows.

1. The Authority hereby authorizes an increase in the cap for JD Organic Landscaping, LLC for their contract with the Authority for an additional \$5,000.00 for a total cap not to exceed \$17,000.00
2. This Resolutions shall take effect immediately.
